Breaches of these terms of use

We will determine, in our discretion, whether there has been a breach of these terms of use.

When a breach of these terms of use has occurred, we may take any action we deem appropriate, which may involve us taking all or any of the following actions (or any other action we deem reasonably appropriate):

- Immediate, temporary or permanent withdrawal of your right to use our website.
- Immediate, temporary or permanent removal of any posting or material uploaded by you to our website.

Which country's laws apply to any disputes?

These terms of use are governed by English law. You and we both agree that the courts of England and Wales will have exclusive jurisdiction save that, if you are a resident of Northern Ireland, you may also bring proceedings in Northern Ireland and, if you are resident of Scotland, you may also bring proceedings in Scotland.
